### **Cementir Holding achieves “B” Rating for climate change from non-profit organization Carbon Disclosure Project (CDP)**

**Rome, 17 December 2020** – Cementir Holding N.V. has been awarded a “B” rating from Carbon Disclosure Project (CDP), recognizing its actions to mitigate climate change and its significant commitment to a low-carbon economy. This result represents a strong improvement from previous “F” rating and puts Cementir amongst the top players in the cement industry and much better than the average company, considering a CDP European and Global average rating of “C”.
